INGESTION:	WASH MOUTH WITH PLAIN WATER, DO NOT INDUCE VOMITING, IF CONSCIOUS DRINK HALF LITER WATER IMMEDIATELY
INHALATION:	REMOVE CASUALTY FROM EXPOSURE ONE'S OWN SAFETY WHILST DOING SO

5. FIRE FIGHTING MEASURES

PROTECTION OF FIRE-FIGHTERS:

WEAR SELF CONTAINED BREATHING APPARATUS,
WEAR PROTECTION CLOTHING TO PREVENT WITH SKIN AND EYES

EXTINGUISHING MEDIA:

7. HANDLING AND STORAGE

HANDLING:
